In continuation of this office letter No. 4-1(33)/2017-PT dated the 22nd September, 2017, I am directed to convey the administrative approval of the competent authority to the continuance of the Scheme 'Project Tiger' in Kaziranga Tiger Reserve, Assam at the cost of Rs. 1564.27 Lakhs (Rupees One thousand Five hundred Sixty Four lakhs Twenty Seven thousand only) enhanced to Rs. 28,35,28,172/- (Rupees Twenty Eight Crores Thirty Five lakhs Twenty Eight thousand One hundred Seventy Two only) to Kaziranga Tiger Reserve, Assam during the year 2017-18. The enhancement of amount of Rs. 12,71,01,172/- (Rupees Twelve Crores Seventy One lakhs One thousand One hundred Seventy Two only), has been sanctioned for 2nd Addition of Land Compensation (Area 25.51 Ha.) of APO for 2017-18 to the Kaziranga Tiger Reserve, Assam as per details given in the annexure. The above cost of the scheme will be treated as 90% Central Assistance by the Government of India and 10% assistance by the State Government of Assam for non-recurring components.

- 2. I am also directed to convey the sanction of the President to the payment and release of an amount of Rs. 3,35,98,100/- (Rupees Three Crores Thirty Five lakhs Ninety Eight thousand One hundred only) to the State Government towards the Grants-in-aid to Government of Assam during the current financial year 2017-18.
