Summary record of the meeting held at NTCA, Hqrs, New Delhi regarding the implementation of Sabarimala Master Plan on 09.10,2018.

A meeting of the committee regarding the implementation of Sabrimala Master Plan was held on 09.10.2018 at the Conference Hall, of NTCA, HQrs. New Delhi under the Chairmanship of ADG (PT) & Member Secretary (NTCA). The details of the participating officers are placed at Annex. I. At the outset, the Chair welcomed the participating officers and briefed about the importance of Master Plan implementation at Sabrimala. The Chair briefed that the master plan details out the development vision for short term and long term activities at Sabrimala. It was also informed that a meeting was held at NTCA HQrs. on 25.04.2017 to discuss the implementation of the master plan.

During the discussions, it was brought to notice of the Chair that Phase I of the master plan contained a layout out plan for base camp at Nilakkal along with immediate interventions for water supply, sanitation, solid waste management, parking and road facilities at Nilakkal, Pamba and Sannidanam prior to pilgrimage season. The phase II of master plan prepared by M/s Eco Smart Ltd has a perspective of 50 years vision projecting all aspects of site specific requirements. The master plan is divided into various modules viz. regional, infrastructure, landscape, built fabric analysis, including the disaster management plan to deal with natural/manmade disaster. The master plan aims to manage the Sabarimala temple complex and the surrounding region in a complimentary and eco-friendly manner so as to provide satisfactory experience to pilgrims visiting the holy shrine. In the meeting, during discussion & deliberations, it was informed to the Chair that several supervisory visits by the different committees of MoEF&CC, agencies and officers of the State Government of Kerala had been conducted to review the implantation of Sabarimala Master Plan. The observations regarding the implementation of the provisions along with the action points decided are summarized as under:
