The undersigned is directed to enclose a copy of DoE's O.M. No. 1/(08)/ PFMS/ 2022 on the above mentioned subject.

- 2. DoE has referred to its earlier O.M. on the subject issued on 23<sup>rd</sup> March, 2022 and corrigendum dated 21<sup>st</sup> June, 2022 and stated that references have been received by it on whether the conditions enumerated in the said OM will be applicable for release of 1<sup>st</sup> instalment of funds in 2023-24.
- 3. In this regard, DoE has decided that the instruction contained in OM dated 23<sup>rd</sup> March, 2022 will be applicable for release of 1<sup>st</sup> instalment of funds under a CSS in 2023-24.
- 4. DoE has, further, stated that the condition (v) of the aforesaid OM regarding fund available in the bank account of SNA should not be more than 1<sup>st</sup> instalment of central share likely to be released including corresponding State share is inconsistent with the DoE's guidelines that an instalment of funds may be released only after utilization of 75% of funds released earlier. Therefore, it has been decided that point no (v) of the aforesaid OM may be read as-

"Funds available in the bank account of SNA should not be more than 25% of the 1<sup>st</sup> instalment of central share likely to be released to the State in a Financial Year including corresponding State share."



References have been received in this Department on whether the conditions enumerated in the aforesaid OM will be applicable for release of 1<sup>st</sup> instalment of funds in 2023-24.

- 2. In this regard, it has been decided that this Department's instructions dated 23<sup>rd</sup> March 2022 will be applicable for release of 1<sup>st</sup> instalment of funds under a CSS in 2023-24.
- 3. Further, it has been brought to the notice of this Department that condition (v) of the aforesaid OMs regarding fund available in the bank account of SNA should not be more than 1<sup>st</sup> installment of central share likely to be released including corresponding State share is inconsistent with the DoE's guidelines that an installment of funds may be released only after utilization of 75% of the funds released earlier. Therefore it has been decided that point no (v) of the aforesaid OMs may be read as –

"Funds available in the bank account of SNA should not be more than 25% of the 1<sup>st</sup> installment of central share likely to be released to a State in a financial year including corresponding State share".
