- 2. The officers should have completed the requisite 'cooling off' period in their parent cadre before they are recommended for a second central deputation.

If an officer does not join within the prescribed time, his appointment would be treated as cancelled and the officer concerned would stand debarred from Central deputation for a period of five years from the date of issuing orders of his/ her appointment. Further, the officer would be debarred from being considered for any foreign training as also from being given cadre clearance for being deputed on foreign assignments / consultancies abroad during period of debarment.
- 4. The officers debarred for central deputation should not be sponsored for consideration for the post of DIGF till they complete their debarment period / become eligible for consideration.
- 5.
